2014 ASE POST GRADUATE STUDENT COMPETITION

The Executive of the Australian Society of Endodontology Inc is pleased to announce the 2014 Post Graduate Student Competition. Post Graduate students and recent graduates of post-graduate courses are invited to submit a case report for this competition. The details are listed below

ELIGIBILITY:

1. All entrants must be members of the Australian Society of Endodontology Inc. and
2. All entrants must EITHER
 - a) be enrolled in and currently undertaking a postgraduate degree course at a Dental School of an Australian or New Zealand university,OR
 - b) have completed a post graduate degree course at a Dental School of an Australian or New Zealand university within 12 months of the closing date for submission of entries.

TOPIC: A case report regarding endodontic treatment, or of relevance to endodontics. A specific title should be chosen by the author to demonstrate the scope of the report.

CONDITIONS & NOTES:

- The report should conform to the "Guidelines for Contributors" to the Australian Endodontic Journal - as published in each issue of the Journal.
- Limit of 30 references.
- Reports may be edited and published at the discretion of the Editor.
- Three hard copies, 3 copies on diskette or CD, and 3 hard copies of any attachments (e.g. radiographs) of the case report must be submitted and neither the name of the author, nor marks identifying the author, should appear on the case report. The candidate's name, home address, email address and University name should appear on a separate front page attached to the report. Case reports will be coded for anonymity and sent to judges appointed by the ASE Inc. Executive.
- All reports must be submitted by one author only. Joint submissions will not be considered. However, other persons directly involved with the case report and/or treatment should be acknowledged on the front page.
- A candidate may submit only ONE case report.
- The decision of the judges shall be final. No correspondence shall be entered into concerning the result. Should no entry be considered of suitable merit no prize will be given.

PRIZES: FIRST PRIZE \$1500.00 Plus a commemorative plaque.
 SECOND PRIZE \$750.00
